



**JOHN W. POTTER MEMORIAL
SCHOLARSHIP APPLICATION 2024**

Reliance Credit Union is proud to sponsor the “**John W Potter Memorial Scholarship**”. The scholarship is about the spirit of giving which is best reflected by John himself. John came to work at BPU in 1971 and retired in 2008, after 37 years of service. He became involved with the credit union not long after he went to work at BPU. John started off as a volunteer on our Credit Committee and later became a Board Member in 1992. He remained a Board Member until his passing in January of 2018, committing over 45 years of service as a volunteer for the Credit Union.

This scholarship is to pay tribute to the type of man that John W Potter was. It can be best understood by this quote from a current Board Member of Reliance Credit Union:

“I only had the opportunity to work with John a short time on the Credit Union Board of Directors. During that time, I observed John’s passion for the Credit Union members, Board of Directors, and its employees. I recall John often expressing his commitment during board discussions that as directors to always do what was in the best interest of the CU, which made an influence on me. John wasn’t afraid to go against the grain for the right reason. He stood up for what was right and just. He could see through the smoke screen that was occurring at that time in the credit unions history and John took it personal to ensure the CU was at its best. There were other times when John was quietly listening to the board conversation, soaking it in, you could see the expression on his face and tell if he agreed or not! John and I had a couple good conversations regarding the CU and its direction, he welcomed me as a new member to the Board and made sure I understood how important it was to be a member. I often recall John being the historian, telling stories of the CU which as a new member I appreciated, and found very valuable. I believe his spirit is still there with us when we meet now.”

The applicant must be a college-bound, graduating senior with a cumulative weighted high school GPA of 3.0 or above and attend a high school located within one of the following counties in Kansas: Johnson, Wyandotte or Leavenworth.
- B. **Amount of Award:**
Reliance Credit Union is awarding 3– \$500.00 scholarships.
